6. <u>NOMINATIONS AND ELECTION OF OFFICERS</u>: Post Commanders are encouraged to review Section 217 of the National Manual of Procedure "Nomination, Election, Installation and Term of Office." Nominations and elections shall be held at the Post meeting in April. The current Post Commander is responsible to ensure a completed 2024-2025 Post Election Report is submitted to National and State HQS by June 1<sup>st</sup>. The current Post Quartermasters is capable of submitting the election report via OMS.

7. <u>CONVENTION BOOK ADVERTISEMENTS</u>: We are asking Posts, Districts and Auxiliaries to purchase an advertisement in the State Convention Book. We are also asking members to solicit local businesses to purchase an ad. The intent is for the purchase of ads to cover the cost of the Saturday evening banquet, making attendance at the banquet free of charge. 8. <u>POST DELEGATES TO THE DISTRICT AND STATE CONVENTION</u>: Post Delegates shall be elected in April. Posts are entitled to one delegate per 30 members and fraction thereof based on the total number of members as of March 31<sup>st</sup> (e.g. if a Post has 31 members as of March 31<sup>st</sup>, they are entitled to 2 delegates.) The State Adjutant will notify each Post of their delegate strength and State Convention Delegate Fee the first of April. Post Quartermasters can view their Post's delegate strength in OMS. Posts are to provide a list of delegates to the District Quartermaster and State Quartermaster. A delegate or alternate listed must be present at the District Convention and State Convention to cast the Post delegate strength when voting.

9. **<u>RICH HOMAN MEMORIAL AWARD</u>**: This award will be presented to an outstanding VFW member who is a member in good standing with a Post in West Virginia. The recognition will be awarded for a comrade's community service, promoting the objectives and values of the VFW throughout the community, and VFW achievements such as Membership Programs, Community Activities, Youth Activities, Project Chairman, and the leadership they have demonstrated at their Post that has brought prestige to the VFW. *All nominations must be submitted in writing to State Headquarters no later than May 1st.*

Dear Post Quartermaster:

Enclosed with this letter is the very important **Post Election Report**, which must be completed and immediately filed with VFW National Headquarters following your annual Post election in April. Although it is the responsibility of the Post Commander under Section 218(a)(1)(i) of the National Manual of Procedure to ensure the filing of the report for the ensuing year, you as Post Quartermaster have access to the membership and Post records which are needed to properly render the report. We are therefore requesting you complete the form online to ensure its accuracy. It is important that a Post Election Report be completed online even if there are no changes in the elected and appointed officers for the ensuing year.

To continue our commitment to better use our financial resources, I am encouraging every Post to file their report using the Online Membership System (OMS). This enhanced system allows you as the Quartermaster an opportunity to efficiently and effectively report the Post's newly elected and appointed officers.

Once you've successfully entered the new data and properly transmitted, a copy of the election report is automatically sent to the email address of the person completing the form and to your Department Headquarters.

Please be reminded that Section 211 of the National Bylaws stipulates authority to the Commander-in-Chief, to suspend and eventually revoke a Post Charter for failure to submit a properly completed Post Election Report to this Headquarters by June 1.

You will also find enclosed the **National Convention Post Registration Invoice**, which must be completed and filed in advance of the National Convention. Section 222 of the Veterans of Foreign Wars Bylaws requires each Post to pay in advance a National Convention registration fee of \$25.00. This shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a \$10 delegate fee. Each Post is encouraged to register at least one delegate and one alternate for every thirty members or fraction thereof. *Please note that Section 222 of the Manual of Procedure states that delegates shall be elected at the regular meeting in April, with delegate strength based on members in good standing as of March 31.* 

Like the Post Election Report, the National Convention Post and delegate registration process is available to Quartermasters through the Online Membership System (OMS). Only a Post or Department Quartermaster can register a Post and its delegates online.

For your convenience, we are providing complete instructions on how to accomplish these two very important processes, as well as the OMS alternative methods.

I appreciate your cooperation on these matters.

- Current Post dues amount
- Commander's named appointments for Adjutant, Chaplain and Service Officer (Judge Advocate and Surgeon if required by Post bylaws).

#### **ONLINE ELECTION REPORT**

Online reporting is the preferred method of submitting the Post's 2024-25 Election Report. As Post Quartermaster, you will log into <u>vfw.org</u> accessing "My VFW." You will then click on the link "Online Membership System." You will find, in the left navigation pane "Election Report"; open the drop down and click "Post Election Report Filing." You are now ready to use the newly enhanced reporting procedure. Follow the step by step process, verify your summary, make any necessary corrections and submit. This is a 5-7 minute process for the average user.

Quartermasters who need assistance setting up their Online Membership System (OMS) account should review the "Quartermaster Guide to Member Dues Processing" training document located in "VFW Training and Support" under "Member & Officer Training, Forms & Templates." Additional technical support is available by calling VFW Member Service Center at 833.VFW.VETS (833.839.8387).

# POST CONVENTION REGISTRATION, DELEGATES, ALTERNATES AND ATTENDEES

# NATIONAL BYLAW - SECTION 222

Delegate strength shall be <u>one for every thirty (30) members</u> or fraction thereof in good standing. Delegates and alternates shall be elected in accordance with the Manual of Procedure.

Each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee.

# NATIONAL MANUAL OF PROCEDURE - SECTION 222

Delegates and alternates for the National Convention shall be elected at a regular meeting in April. Delegate strength will be based on members in good standing as of March 31.

#### <u>ONLINE</u>

Online submission is the preferred method of submitting the National Convention-Post & Delegate Registration Fee(s). As Post Quartermaster, you will log into <u>vfw.org</u> and access "My VFW." You will then click on the link "Online Membership System." You will find, in the left navigation pane "National Convention"; open the drop down and click "National Convention Registration" and enter desired membership information. This is a 3-6 minute process for the average user. <u>Please have the</u> <u>membership number available of all delegates, alternates and attendees you are registering.</u>

# Only a Post or Department Quartermaster, utilizing this system, can register the Post's delegates online. Members accessing the National Convention website are registered as attendees only.

The Post registration fee of \$25 must be remitted *prior* to the convention; Post delegates will not be able to register their credentials unless this fee is paid.

#### MAIL-IN OR FAX

Enclosed with this notification is an invoice in the amount of \$25. Quartermasters may fill out and return this invoice using the enclosed pre-addressed, postage paid envelope. This form must be signed by the Adjutant or Quartermaster. The Post registration fee of \$25 must be remitted *prior* to the convention; Post delegates will not be able to register their credentials unless this fee is paid. When using the enclosed form you are required to include the membership number, name and address of all delegates, alternates and attendees you are registering.

#### DEFINITIONS

- Delegate- Member (in good standing) of the Post elected to represent the Post in all business activity at the National Convention. Delegates elected under Section 222 of the National Bylaws and Manual of Procedure shall not be considered instructed and may exercise full authority in the duty performed.
- Alternate- Member (in good standing) of the Post elected to represent the Post in all business activity at the National Convention in the event the elected delegate cannot attend. Alternates not fulfilling the role as "delegate" are considered "attendees."
- Attendee- Any member in good standing may register for the National Convention. Registering for the National Convention is another way a member can show support for VFW programs. The \$10 registration fee entitles the member to a convention packet which may be picked up at the convention.

#### NOTIFICATION

Post Quartermasters will receive letter confirmation that the Post is registered.

Delegates, alternates and attendees will receive a confirmation letter. Included in this letter will be a request for emergency contact information. We are asking all to fill-out and bring this form with them to convention; this is voluntary, but recommended.

All notification will be sent USPS, 3-5 days after processing.

# What is the Voice of Democracy Program?

Since 1947, the Voice of Democracy has been the Veterans of Foreign Wars' (VFW's) premier scholarship program. Each year, nearly 27,000 high school students compete for more than \$2 million in scholarships and incentives. Students compete by writing and recording an audio essay on an annual patriotic theme. This year's theme is, **"What are the greatest attributes** of our Democracy?"

# Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, state and national level. Department (State) winners receive an all-expense-paid trip to Washington DC, to tour the city, be honored by the VFW and its Auxiliary and receive their portion of \$171,000 in national awards, the top scholarship being \$35,000.

# The Rules

#### Who can enter?

The Voice of Democracy is open to students in grades 9-12 by the Oct. 31 deadline who are enrolled in a public, private or parochial high school or home study program in the United States, its territories and possessions; or dependents of U.S. military or civilian personnel in overseas schools. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application for which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. Foreign exchange students, students age 20 or over, GED or Adult Education Students are ineligible.

#### What do I need to enter?

Record your original 3-5 minute (+ or - 5 second max.) audio essay on a flash drive, or other electronic device. You will submit the recording, typed essay and this completed entry form. Provide these items to your school/group competition or VFW Post for judging. In addition you can submit your emailed entry form, essay, and audio file to the VFW Post upon approval. You must be the sole author of your essay. Inappropriate use of ChatGPT or or other AI tools is not allowed. The recording must be in your own voice and in English. Hearing/speech impaired students should email the Voice of Democracy National Office at youthscholarships@vfw.org for special instructions. No music, singing, poetry or sound effects are allowed. The body of the essay must not identify you in any way, (including, but not limited to your name, school, city, state, race, or national origin) although the recording & typed essay should be labeled with your name, to show ownership.

### Where Do I Submit My Entry?

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post. Entries sent to VFW National will be returned. One winner for every 15 entries from each Post advances to District and one District winner advances to the state (Department) competition. If you need help finding a participating VFW Post, follow these instructions: First, visit this website vfw.org/FindaPost to "Find A VFW Post." If you do not have success in finding a Post, or if you have trouble getting in touch with them, you can contact your VFW Department (state) office to see if they can offer any information or assistance. You can visit this link https://www.vfw.org/ ContactUs/ and look for "Find a State Contact" to get your VFW state office's phone number and email. # What Is the Deadline for My Entry?

All entries competing at the Post level must be in the hands of that VFW Post by midnight, **Oct. 31, 2024**. It is the responsibility of the student to meet this deadline by submitting their entry to the proper location by ensuring it is a participating Post.

# What Are the Judging Criteria?

#### Originality is worth 30 points:

Treatment of the theme should show imagination and human interest.

#### Content is worth 35 points:

Clearly express your ideas in an organized manner. Fully develop your theme and use transitions to move smoothly from one idea to another.

#### Delivery is worth 35 points:

Speak in a clear and credible manner.

# What is the Patriot's Pen Program?

Conducted nationwide, this VFW-sponsored youth essay competition gives students an opportunity to write essays expressing their views on an annual patriotic theme. We invite you to join the more than 73,000 students who participated last year in this contest.

# Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, State and national level. Department (State) winners receive a portion of \$55,000 in national awards. National Winners will receive at least \$500. **The first-place national award is currently \$5,000**.

The Internal Revenue Service requires a recipient awarded more than \$599 be given Form 1099 identifying the proceeds as taxable income. This may require the winner to provide their social security number.

### How Does the Contest Work?

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post.

The contest consists of four levels. The first level (entry) is sponsored by VFW Posts. Post winners advance, one for every 15 entries, to the VFW District (regional) level where the one first-place winner is advanced to the VFW Department (state) level. The first-place winner at the Department level is then advanced into the VFW national competition.

### Who Can Enter?

Patriot's Pen is open to 6th, 7th and 8th-grade students enrolled by the Oct. 31 deadline in public, private or parochial schools in the U.S., its territories or its possessions; or dependents of U.S. military or civilian personnel in overseas schools. Home-schooled students also are eligible. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. (Foreign exchange students are ineligible.)

### How Do I Get Started?

- Ask a teacher or youth group/club adult leader to supervise the Patriot's Pen writing contest.
- Contact a participating VFW Post and indicate your interest in participating.

- Establish a contact person who is a member of that VFW Post or its VFW Auxiliary.
- Make sure that your essay is submitted to the VFW Post before the contest deadline of October 31, 2024. You can submit your essay and entry form by email upon the Post's approval. Entries sent to the VFW National Headquarters directly will be returned.

## How Am I Judged?

**Knowledge of the theme is worth 30 points:** You must show a thorough knowledge of the theme in your

work. Demonstrate you have researched the issue extensively.

#### Theme development is worth 35 points:

Answer all relevant facts about the theme such as the who, what, where, when and why. Relate the theme to your own experiences.

#### Clarity of ideas is worth 35 points:

Write your essay in an easy-to-understand format. Leave your reader with a clear understanding of your explanation of the theme.

### What Is the Theme?

VFW's Commander-in-Chief annually chooses the year's theme. The 2024-2025 theme is:

### "My Voice in America's Democracy?"

To qualify, all entries must be submitted to a sponsoring VFW Post by midnight October 31, 2024.
